This year the festival will be **Friday evening, May 14 and Saturday, May 15, 2010** (**NOTE NEW DAYS: We added Friday, and there is NO Sunday!**).

There will be a wide variety of entertainment, more parking, a large children's area and, as always, we will have a fireworks display on Saturday evening. Vendors will have the best of both worlds with a beautiful beach setting, located on a clean, paved area.

Attached is an application for entry. Your submitted application, with payment, does not ensure acceptance. Booth location assignments will be made at the discretion of the Committee. **To be considered you must submit:**

1. Complete application form with a signed liability disclaimer.
2. Photographs representative of the items you are presenting (arts & crafts vendors only)
3. Registration fee of **\$100 before March 30th** or **\$150 after that date until April 30th**.

2010 NAVARRE FUN FEST ARTS & CRAFTS VENDOR – PART 1 (GENERAL INFO)

- **Location:** Navarre Beach intersection of Gulf Blvd & Navarre Causeway
 - **Entry Fee:** \$100 (on or before March 15th) or \$150 (until April 30th)
 - **Dates & Times:** Fri, May 14, 2010 – 4 p.m. - 10p.m., Sat, May 15 - 10 a.m. - 8:00 p.m.
1. Spaces are 10 x10. The vendor fee that is paid is for the space only. The Chamber **does not** provide a tent, tables, or chairs. Any special needs should be indicated on your application. The committee will TRY to accommodate your requests.
 2. Entry fee and signed release form are due with application. **Your application will not be reviewed without it.** Application and fee are not a guarantee of acceptance. This fee will be returned in full if your application is not accepted. No refunds will be given to accepted vendors after May 1st, or for weather, acts of God, civil disobedience, or any circumstances Navarre Chamber of Commerce deems out of its sole care, custody or control.
 3. Acceptance in the show is a commitment for you to show all hours listed above. Vendor hours are different from food and entertainment hours. **This is not a night show;** however, if you wish to stay open after sunset, you may use battery-powered lighting. * Note: We are trying to make extra provisions to have overall lighting that would facilitate the night hours.
 4. Acceptance and assignment space in the show is non-transferable and cannot be shared. Only the artist/craftsperson on the application may show in the booth space. Booth space cannot be shared. The Committee reserves the right to remove misrepresented or inappropriate material from the show. Only the Navarre Chamber of Commerce may sell or giveaway Fun Fest related materials, included but not limited are: Fun Fest T-shirts, posters, bottled water and glow sticks.
 5. Exhibitors are responsible for collecting and reporting Florida's Sales Tax.
 6. Shade is not available. Exhibitors are encouraged to use a freestanding 10x10 canopy. Should rain occur, no vehicles would be allowed into the parking lot within the barricaded area of the festival site.
 7. Navarre Chamber of Commerce will provide continuous security. However, it is the vendor's sole responsibility to provide for his own protection. The Navarre Chamber of Commerce assumes no liability for loss, damage, or misplacement of merchandise and equipment from any or all causes.
 8. No animals will be allowed except guide dogs used by blind persons.
 9. Vendors may not utilize music, loudspeaker systems, or megaphone devices. **NO generators are allowed.** No trailers, cars, wagons, or carts will be left in the area after unloading on ANY day of the festival.
 10. No one may check in early under ANY circumstances. You will be notified in writing of set-up time and complete festival details no later than May 5th, booth space number will be posted on the chamber website.

VENDORS – PART 2 (CONTRACT & RELEASE)

I understand and agree with the rules and regulations that are set forth in this application and agree to abide by and fully comply with said rules. I understand and agree that the Navarre Chamber of Commerce are not responsible in any way for damage, loss or theft of me, my firm or of my customers and agree to indemnify and hold harmless the Navarre Chamber of Commerce and the FunFest Committee against such loss, damage or theft.

In the event that the Navarre Chamber of Commerce are unable to hold the 2010 Fun Fest as scheduled by reason of war, acts of God or acts of nature, or any other reason, or the Festival is interrupted in any way, no refund shall be made and it is agreed that all contracts are null and void.

There shall be no responsibility or liability on the part of the Navarre Chamber of Commerce for any losses sustained by any person caused by such event. The Navarre Chamber of Commerce in no way guarantees any return or benefits to vendor.

It is further agreed and understood that the Navarre Chamber of Commerce assumes no liability for any injury to person or property or any other damages or losses occurring in the Festival premises during FunFest. I agree to forever indemnify and hold harmless the Navarre Chamber of Commerce from and against any and all claims for loss, death or damage of person or property and any other loss whatsoever arising out of any act, omission or negligence in the operation or conduct of me/my business, including violation of any law, and all attorneys' fees and costs incurred by those parties.

All the foregoing is agreed to in consideration of and as a condition precedent to the Navarre Chamber of Commerce providing to me/my business the applied for vendor space. The indemnification provisions shall survive after the 2010 FunFest.
